Builder/Remodeler Rebate - Receive Up To \$1,800 In Rebates

Participation Details

- > Submit completed registration form and invoice(s) showing Qualifying Products purchase from January 1, 2012 to December 31, 2012 to the following address:

- > After submitting this initial registration form, continue to submit invoices of purchases through December 31, 2012 that clearly indicate Qualifying Product, quantity purchased and company name up to the 300 panel limit per Qualifying Product.
- > Invoices must show building company name and must show type, quantity and price paid of/for Qualifying Products purchased.
- > **All registration forms must be postmarked or faxed within 30 days of the purchase date listed on the invoice and received within 45 days of purchased date listed on the invoice to be eligible for rebate.**
- > Purchases made by homeowners on behalf of their builder can not be accepted. Purchase must be made by professional building company to be eligible for rebate payment.

Rules and regulations: Rebate is available to professional building/remodeling companies only. Rebate is not available outside the United States. Eligibility for the rebate may be independently verified at Huber's sole discretion. Rebate cannot be combined with any other promotion. Maximum rebate of \$1,800 per building company. Sales Person Maximum is \$300 per Qualified First Time User-Builder/Remodeler Completed registration form and valid invoices must be submitted by deadline to qualify for rebate.
